1. Information We Collect

We collect the following types of information when you use our Services:

- **Email address**: Collected when you create an account or interact with Services requiring authentication. This serves as your primary identifier.
- **Al usage data**: Inputs and outputs from the Al Form Builder are stored to better understand how users interact with the tool and to enhance the overall user experience.
- **Analytics data**: Information that your browser sends such as your IP address, browser type, operating system, referring URLs, pages visited, time spent on each page, and general usage patterns to help us understand how the Services are used.

2. How We Use Your Information

We use the collected information to:

- Authenticate users and provide access to certain features
- Improve the Al capabilities of our Form Builder
- Understand how users interact with our Services
- Communicate with you about updates or support requests

3. Purchases

If you choose to purchase paid features (such as access to the UI Kit), your payment will be processed by **Polar**, our authorized reseller and Merchant of Record.

- We do **not** store or have access to your payment details.
- Polar may collect personal and payment information required to complete the transaction.
