- Resell or redistribute the UI Kit as a standalone product
- Claim ownership of the original unmodified components

The UI Kit is licensed, not sold.

3. Use of the Al Form Builder

The AI Form Builder generates code snippets based on your input. These snippets are meant to work with the UI Kit.

You agree not to:

- Misuse the tool to generate harmful, illegal, or abusive content
- Reverse engineer or attempt to access internal systems

We store input/output data to improve the service. All use is subject to our Privacy Policy.

4. One-Time Payments

Certain Services (e.g. UI Kit access) may require a one-time payment.

All payments are securely processed by **Polar**, our authorized reseller and Merchant of Record. By making a purchase, you agree to Polar's Terms and Privacy Policy.
